Trinity Lutheran Church Council set a 2022 goal to create a 5-year ministry plan. To achieve this goal the Council created a special Faith Forward Committee. This committee generated a report of potential actions based on feedback and ideas from the congregation. The Council and associated boards reviewed the committee's report and prioritized actions.

The Council and associated boards are committing to this Faith Forward Plan and its actions.

"¹² For just as the body is one and has many members, and all the members of the body, though many, are one body, so it is with Christ. ¹³ For in the one Spirit we were all baptized into one body—Jews or Greeks, slaves or free—and we were all made to drink of one Spirit." 1 Corinthians 12: 12,13

Dear friends in Christ,

The phrase "body of Christ" is used in several different ways in the church. Jesus Christ walked among his people in a physical body, and his body rose from the dead on the first Easter. When we gather to receive Holy Communion, it is the body of Christ that we receive. In this letter, I'd like to emphasize a third use. The church is the body of Christ. The theologian Dietrich Bonhoeffer reminds us that the church community is the way that Jesus is physically present to the world today.

In 2023 Trinity Lutheran Church functioned as the physical presence of Jesus to thousands of people by proclaiming the gospel in word and deed. I encourage you to spend time reading through this full report. You will see the names of those who were baptized, confirmed, or died, as well as the many who joined this community of faith. You will see the important ministry generated through the ministry boards, whether that work was feeding the hungry, studying scripture together in large and small groups, providing ways to support one another in times of sadness, building connections with neighbors next door and with ministry partners around the world, or giving people opportunities to be good stewards of God's gifts. Many people grew in their personal faith and in their service toward others because of Trinity's work this year.

I am deeply grateful for the faithful work of the many leaders of the congregation and for the hundreds of volunteers. We are fortunate as a congregation to have a talented and dedicated staff as well. Several areas of ministry that I will particularly remember from 2023 include the deep generosity of the congregation in response to the "Under this Roof" campaign in the winter and the "Trinity: In It Together" campaign in the fall. My personal faith and knowledge of scripture was deepened by a study trip to the Holy Land in January. As we have all been praying for peace in the middle east, I have been remembering individuals I met there in prayer as well. It was a privilege to serve along with our high school youth at their work camp experience in Wausau, Wisconsin and to accompany confirmation students to summer camp. I also have valued the important individual pastoral conversations that have taken place in hospital rooms, homes and throughout the community.

Trinity Lutheran Church continues to be a healthy congregation that is known in the community for its spirit of service to others. It is good to serve as the body of Christ together.

Dear Beloved of Trinity,

Does anyone else find themselves in a juxtaposition? At times, this past year has seemed to have gone by so quickly and other times this past year trudged on like a turtle. No matter which side you fall on, one thing is true, we give God thanks. Just like the bible verse above, whatever we do, we do it in the name of Jesus, giving thanks to God through him.

As I look at the past year, there are many reasons to give thanks as we acknowledge our mutual achievements and highlight our progress into the future.

As one of your ministers, I have the distinct pleasure of working alongside of you in serving our Lord. As a Minister of Word and Service, the "word" part involves planning and leading worship and preaching. It is a privilege to be able to proclaim the good news of Jesus.

The "service" part allows me to provide opportunities for us to strengthen our faith by living out Matthew 25:35-40. "when I was hungry, you gave me food, When I was thirsty, you gave me a drink, etc." But the people ask, "when did we see you hungry and give you food? When did we see you thirsty and give you a drink, etc.? And Jesus says, "when you did it to the least of these, you did it to me." My friends, we do acts of service, not because it gains our entrance into heaven but because we are living out our faith. Some areas that we teamed up on were: Giving Tree, school supplies and backpacks, God's Work Our Hands and Church on the Street.

Helping others discover their gifts for leading worship has been an enjoyable part of my call. With Casey Bullis, I helped prepare 5th and 6th graders to lead a worship last spring. I meet with our High Schoolers each spring as they prepare to lead all our Easter services and play in the brass band, a tradition set many years ago. A shared ministry, a shared service, helps foster a sense of unity and encourages positive outlook. It is not uncommon to get a text from one of the schools in need of coats, hats, mitts, underwear, etc., and we are able to fill those requests. There are also individual requests from food pantry clients and we've filled those also. I am proud of the positive impact Trinity has made in the community.

One of the best times this past year was creating and implementing the Bible Crash Course. The idea came from my sabbatical in 2021. I had created a 15 week sermon series called, Tell the Story, Be the Story so this Bible Study was a spin-off of that. Fifty-nine of you signed up as we met for 4 weeks to walk through the entire Bible. Well, done, friends!

I am so grateful for my colleagues in Christ; Pastor Tom, Janita, Laurie, Carrie, Clarissa, Zach, Molly, Dave and Cole. We are a good team.

I look forward to another year of mutual ministry with you . May the coming year be filled with continued growth, deepened connections and an unwavering spirit of service. I thank God for you.

It's been an eye opening 3 years on Church Council. First year serving as chair of our Board of Worship and Music and then the last 2 years serving on Executive Council including Vice President and now President. For the longest time, my church experience consisted primarily of attending church with some sporadic volunteer work. Having the opportunity to serve in a leadership capacity on Council, I've gained a visibility and understanding of what it truly takes to run a church of our size. The dedicated staff, the numerous boards and their roles, the countless volunteers we have and the number of hours they so willingly give, all the ways our Mission impacts the needs of the congregation and community we serve, and Yes; the \$'s it takes to operate Tea Trinity. I have an appreciation, a connection, a genuine care for this church, and ultimately; a deepened faith that doesn't come to be without serving.

Some interesting stats:

- Percentage of people belonging to some form of Christianity decreased from 52.2% to 43.9% in 2021
- Those declaring they had no religion increased from 30% in 2016 to 38.9% in 2021
- Nearly 1/3 of Americans now say they seldom (28%) or never (29%) attend religious services

Despite all of these downward trends in religion, Tea Trinity numbers remain stable if not growing:

- Our congregation numbers just shy of 1,500 people.
- We added 52 new members in 2023 / 19 families.
- Our youth participation #'s remain strong:
 - Sunday School 118
 - KFC 42
 - 7th/8th grade confirmation 64
 - Confirmands 28

Our Church has shown great resiliency and perseverance thru COVID, record inflation and a challenging economy, social distractions, and facility issues. Our Church has staying power. So what is it about Tea Trinity that makes this continue to work, continue to stick? There isn't one answer, but many:

- The first is leadership.
 - We are fortunate to have 2 Senior leaders with close to 60 years of combined ministry experience. They are committed, servant leaders, whose dedication to this Church has been the foundation of our continued progress.



- Church boards. Tea Trinity is comprised of numerous boards all made up of dedicated volunteers with an array of skill sets that our Church benefits from. The leadership and direction that comes out of these boards drive the accountability and structure our Church needs.
- Dedicated staff. We have a small staff of individuals that run lean and hard, motivated by the impact their work makes. A sincere Thank You to Janita Holman, Zach and Molly Gors, Dave and Cole Anderson, Carrie Corner, Laurie Parsons, and Clarissa Roemen!
- Our Church, Our Congregation lives our Mission to Encourage, Inspire, Serve. It's infectious.
 - We are a constant presence in our community:
 - Serving at the Banquet West
 - CommuniTEA Area Picnic at Tea Pot Days
 - TeaPot Days Parade clean up and booth.
 - Winter gear donations
 - Tea Community Food Distribution
 - Food pantry donations including a Giving Tree that supports food pantry clients
 - Dave Ramsey Financial Peace University class
 - Community Outreach Group tLINK
 - We offer numerous educational opportunities including WELCA Bible Study, Bible Crash Courses, Adult Bible Studies, Over 55 Group, Wednesday's Men Group.
 - A strong commitment to the Benevolences we support
 - We've updated our church Photo Directory
- We are vested in our Youth:
 - Preschool Chapels
 - Milestone ministry
 - Strong participation in our WV national youth gatherings
 - KFC
 - A growing Sunday School program
 - A faith based Preschool



- We are a fiscally responsible Church with a Congregation that continually answers the call when asked:
 - Our spring auction had a goal to raise over \$10k and we crushed it, raising \$16k plus!
 - Our "Under this Roof" campaign raised over \$100,000 allowing us to replace heat air exchangers, the roof, and the bell tower. Large and necessary improvements to our facility.
 - We continue to move closer to having our mortgage paid for. Roughly 3 years left.

For the sake of trying to keep this report somewhat short, I will stop with the above but there are many more activities, accomplishments, initiatives that are happening that are moving our Church and our Mission forward. In short, Our People, are our biggest differentiator. We are simply made up of a Congregation that cares more than it doesn't.

I am so very thankful for this opportunity to serve as it deepened existing relationships and was the catalyst for numerous new friendships. I'm proud to call Tea Trinity my church and feel fortunate to be part of this body of Christ that positively supports and impacts so many.

Thank you for financially supporting the important mission here at Trinity Lutheran Church. With your continued offerings we have been able to serve each other and the community with caring ministry.

There are four main funds used for the operation of Trinity. Year end balances are as follows:

General Fund: \$46,900 Improvement Fund: \$115,497 Rental House Fund: \$13,236 Central Bank Mortgage: \$18,255

Money given to the general fund is used to support the church and its ministries. Throughout the year, this fund ran short, so a \$20,000 line of credit was taken out. In the last two months of 2023 several very generous offerings were made one of which was a \$25,000 matching gift challenge. The congregational members exceeded this challenge and the general fund ended the year on a very positive note.

The improvement fund received most of its balance through the "Under This Roof" campaign which ran through the first part of the year. It was originally estimated that the roof repair and replacement/ repair of heat exchangers would cost approximately \$100,000. The roof repairs were less than expected and one heat exchanger was just recently installed. Again the congregational giving far exceeded the ask.

The house to the west of the church building is owned by Trinity. The rental income is placed in the rental house fund to cover any costs incurred to maintain the house. If an excess is realized, the money is moved to the general fund.

The Central Bank mortgage fund is used to hold offerings given specifically for the monthly mortgage payment of \$7,181. The payments are taken from this account.

Three grants were applied for and received also. One grant was for the flat roof repair, one for sound equipment in the sanctuary and one for the monthly food distribution. We also use Thrivent Action Team money to help offset a portion of fund raising, service or educational projects. May we continue to gather and serve while building a bigger and better Christian congregation in Tea.

We also work in conjunction with the Tea School in providing winter gear needs of any child in school. A Thrivent grant was also received this year to assist with this program.

The Outreach Board also worked with Digital Tapestry in photographing members of the church in compiling a new church directory. Members have now received their purchased photos and the hard bound directory as well as the digital directory should become available within the coming weeks.

We are also involved in the Tea Area Community food distribution as well as the I Meals on Wheels programs within the community. 2023 MISSION ENDOWMENT FUND REPORT

Members for the Trinity Mission Endowment Fund Committee are Casey Bullis, Janet Hansen, Amy Kleinschmit – Secretary, Jesse Temme – Treasurer and Wayne Larsen – President.

The Mission Endowment Fund is comprised of two parts. One part is the tracking spreadsheet that tracks designated gifts outside of the general fund, mortgage and improvement fund. The purpose of this spreadsheet is to ensure that designated gifts are used for the purpose they were intended. Please see the spreadsheet below for the 2023 year activity.

The second part is the endowed investment funds. To date there have been \$57,500 deposited in the endowment fund. These funds are currently invested with the ELCA in their Ministry Growth Fund. The current market value as of November 30, 2023 is \$67,118.54. The fund has distributed \$2004.90 back to the church through the first three quarters of 2023. This is typically an annual 4% return on investment on the average market value over the past five year ends. This distribution is typically dispersed by the committee to various areas of need after the fourth quarter distribution.

The committee is currently functioning off of the original by-laws that were approved when the Mission Endowment Fund was established in January 2001. This year the committee worked with the ELCA planned giving group and the church council to revise the current by-laws. These revisions were presented to the church council who voted to submit them to the congregation for approval at the January 28, 2024, annual meeting.

The committee also worked on developing a Trinity Lutheran Church Gift Policy to offer guidance on how to handle gifts of all types that may be donated to the church. The gift policy was presented to the church council and approved at their December 12, 2023, council meeting. The gift policy does not require approval by the congregation.

Terms for the existing members will terminate at the end of the year following their name. Casey Bullis (2023), Wayne Larsen (2023), Amy Kleinschmit (2024), Jesse Temme (2025) and Janet Hansen (2025). Committee members are eligible for two consecutive three year terms.

On October 27, 1889, it was decided that a cemetery was needed. Meinhard Heeren, Sr. donated one acre of land south of the church at that time. The cemetery is presently at that location. Two acres of land were purchased in 1993 north of this location. The church was moved into Tea at 235 S. Mary Ave in 1897. Until January 12, 1949, the cemetery was operated in conjunction with the church council. On this date it was decided to form a cemetery board. The objective was to resolve that our cemetery should no longer be a neglected wilderness of weeds, but a neat, beautiful church cemetery. The cemetery, which is church property, would have to be kept up by finances from the general fund. That created further expenses for the church. The Cemetery Board set up a trust fund after receiving a \$1000 memorial from the members of the Hatie Heeren family. A meeting was held with the church council and the cemetery board. It was decided to form a Cemetery Trust Board. The trust board has their accounts with American Bank and Trust of Tea in the form of CD's. The sale of lots goes into the trust fund. All interest money from the trust goes into the cemetery fund. The two-acre addition to the cemetery was purchased from Iva Haan in 1993 with a private loan and was fully paid off in 1997. The graves are \$600 for non-members and \$400 for members of Trinity. We do not do "Green" burials.

New graves in the north section will be sold in order to keep the cemetery uniform. A cemetery directory has been finished and was dedicated in the fall of 2017.

A group of people from Trinity Evangelical Lutheran Church willing to help people in need...Serving members and non-members alike...Our goal is to tie people in need with people that have time and talents who are willing to serve and assist throughout the community in Jesus' name.

The Faith in Action Committee serves under the Board of Outreach. We served at Food to You Mobile Food Pantry and The Banquet using Globe offerings as our monetary donations to be able to participate. We change and adapt not to conform to the world but because we believe that the gift of God's Son is for the world, and that our congregations and worshiping communities are places to gather and be sent into the world, where we will tell the story of God's love in word and deed.

The ministries of our congregations, our synods and the churchwide organization provide ways for the church to move beyond the boundaries of structures and geography and to share God's love with people in our neighborhoods, our cities, our country and beyond. We engage in this ministry knowing that our church walks by faith, trusting in God's promise in the gospel, and that we exist by and for the proclamation of this gospel word. In John 15:5, Jesus reminds us, "I am the vine; you are the branches. Those who abide in me and I in them bear much fruit, because apart from me you can do nothing." We are connected by the promise that we do all through Christ and can do nothing apart from him.

God gives the Holy Spirit, who uses gospel proclamation — in preaching and sacraments, in forgiveness and in healing conversations — to create and sustain this faith. Just as we rely on God to sustain our faith, we rely on each other to sustain the ministries that offer God's love to the world. Through your generosity to each expression of this church — your congregation, your synod and your churchwide organization — you add to our collective voice proclaiming God's love for all.

I am grateful for your generosity over this last year. My gratitude spreads far beyond your generous financial gifts. You've shared your gifts of time through countless hours of volunteering, serving and accompanying. You've shared the gifts of your voices as we've tried to discover and learn how God is calling us to be the church now and into the future. And, finally, dear church, you have shared the gift of the realness of God's love with the world around you. Be well, dear church, and stand steadfast in the promise of God's love and grace as you take that promise with you into the world.

Dear South Dakota Synod,

On behalf of your close to 200 partners across the South Dakota Synod I come to you to say *thank you. Thank you* for your generosity! Your benevolence to the ministry of the South Dakota Synod doesn't just keep the lights on and pays salaries, but mainly supports ministry on the ground. Please take a look at the "2023 South Dakota Synod Ministry Celebrations" insert included in this annual report. You will notice that YOU showed up in many and various spaces. Sometimes your presence was felt close to home through a grant you may have received or a synod staff that came to visit. At other times your presence impacted ministry in other parts of the world, such as our companion partners in the Lutheran churches in Nicaragua and



Cameroon. *Thank you* also for your generosity above and beyond your benevolence. Our partners in Cameroon appreciated the synod's \$52,000 gift to support putting roofs on churches. The generosity of the congregations in the synod never ceases to amaze me, and I give thanks for your continued generosity as we journey together in Christ!

While many places celebrated an abundant year of ministry, I also want to acknowledge that for other ministry sites 2023 has not been as hoped for. Our mission statement commits us to "Journeying Together in Christ" and is based on Luke 24:13-34. Two disciples are on the road post resurrection and ponder in disbelief all the things that have happened before their eyes. They were overwhelmed and didn't know what to make of it all. I have heard from many ministry sites a similar account about 2023. "Bishop, things in 2023 were not as we had expected and hoped for. What do we do now?" In Luke's story Jesus, unrecognized by them, joins them and walks alongside to listen and remind them of the promises in scripture. But it isn't until they sit down at the table, and Jesus breaks bread that their eyes are opened. They recognize who he is and that the 'holy heartburn' they had experienced along the way was a sign that their love for Jesus and the way he calls them to live has changed them forever.

How about your community of faith? Where do you hear the promises of scripture assure you that God's got a plan for you and your ministry? Where are you called to follow the 'holy heartburn' God's Spirit ignites in you as you are fed at the table of love? I pray that your annual meeting will be an experience where you can voice what you had wished for as well as lament the unmaterialized hopes. And at the same time, you can hear where God promises new life and renewed faith in your very own midst.

Your South Dakota Synod staff and partners across the church are committed to accompany you in your ministry ventures, whether it means to take small courageous steps or giant leaps of faith. We are here to journey with you in Christ. Therefore, it is with great joy and delight that I am announcing to you that we, the South Dakota Synod, are a recipient of a \$1,137,384 grant Endowment Inc. through its Thriving Congregations Initiative. The STAR (Small Town and Rural) Table also offers two types of grants, which are only possible

Last but not least, I would like to invite you to the 2024 Synod Assembly on May 31st and June 1st at Our Savior's in Sioux Falls, SD. We will gather under the theme of "(Re)Connect." I hope to be able to welcome you to the assembly in person, be in conversation with you and hear about ministry in your world and how you might best be accompanied as well as accompany your fellow members of the SD Synod and the ELCA.

2023 MINISTRY CELEBRATION



Our Synod's vision of Journeying Together in Christ has continued to focus our work. We invite you to take a few moments to review the list below which celebrates some of the ministry we shared together in 2023. Journeying together in Christ as the South Dakota Synod, in 2023 we:

- Applied for and received a grant of **\$1,137,384** from Lilly Endowment Inc. through its Thriving Congregations Initiative for new initiatives that are not included the Synod's Mission Plan. Please reach out to Synod Staff for **more information**!
- Completed explorations for two new potential church plants, with plans to start a worshiping community in **Box Elder** and **Shepherd's Table in Sioux Falls**.
- Walked with the 40 people in various stages of Candidacy and have 4 new entrance interviews scheduled in 2024!
- Received **3 new first call candidates**.
- Completed 23 Ministry Site Studies and extended 28 calls!
- Ensured that nearly every congregation has a called pastor, interim pastor, Synod Authorized Minister, or lay leader to care for God's people (thank you to all of you who are helping out with area congregations and filling in!).
- Distributed **\$77,137** to date through the Seminary Debt Reduction Program.
- Granted **\$123,000** in scholarship funds to seminary students, **\$11,400** in internship site assistance, and **\$82,990** to Luther and Wartburg Seminaries, for a total of **\$217,390** in support of seminary education.
- Created a pilot rural J-term program with Wartburg Theological Seminary, which will begin in January 2024.
- Received **\$113,635** in grants from ELCA Christian Community & Leadership.
- Held a **Synod Assembly**, where we gathered again as a community to conduct the business of the synod.
- Hosted **Spring** and **Fall Theological Conferences**, where we continued to support the continuing education of our Rostered Ministers either online or in-person.
- Supported the congregations and ministries of the synod through **visits** by synod staff, both **digital** and in-person.
- Hosted a "Lay Leader Night" to support congregational lay leaders and supported rostered leaders with regular inperson and virtual meetings, such as monthly rostered minister virtual check-ins, Synodically Authorized Minister, Senior Pastor, and Interim Pastor check-ins, and a First Call and Senior Pastor Retreat.
- Pr. Alan Blankenfeld, Synod **Rural Ministry Liaison** continued to journey with our rural ministry sites. In the past year, Pr. Alan has worked directly with **34 communities and congregations in transition**.
- Continued the work of the Rural Ministry Table, which is currently working on **Small Town and Rural (STAR) grants**, grants funded by the generous donations to rural ministry in the Synod.
- Partnered with **Bergen Lutheran** to hold a **Threshing Bee** which resulted in gifts of **\$51,324** to support rural ministry in South Dakota.

Thank you for all the ways you have supported the ministry of the South Dakota Synod this past year! God has called us to be the body of Christ together, and this is an active and healthy body. We look forward to continuing our journey with you in 2024 and beyond! Through your generosity, God is at work across the ELCA.
